Group Walk Rate

45-60 minutes - \$40

Private Walk Rates

30 minutes - \$30

60 minutes - \$50

Cat Sitting Rates

15 minutes - \$20

30 minutes - \$30

Dog walking rates are for 1 dog. +\$10 for additional dogs from same household.

If booking 2 cat sitting visits per day, receive \$5 OFF per visit.

Cat sitting rates include up to 2 cats. +\$5 for each additional cat

Requirements & Recommendations for Dog Walking:

- Up-to-date vaccinations are required for group walks. We recommend keeping all dogs up-to-date on vaccinations.
- Routine flea and tick prevention is recommended to ensure the health & safety of your dog.
- Your dog is required to be spayed/neutered if participating in group walks.
- We do not accept dogs who have exhibited aggression towards other dogs or people. Leash/dog reactive dogs are taken on a case by case basis.
- Ongoing behavior assessments are made for our regular group walk clients. If necessary, we may suggest your dog enroll in private walks instead.

Holiday & Vacation Policies

- Regularly scheduled dog walks are not offered on major holidays. Cat sitting services are offered based on availability for a 50% surcharge. Holidays include New Year's Eve, New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Thursday & Friday, Christmas Eve and Christmas Day. If special circumstances arise and additional services are needed, they can be requested but not guaranteed.
- Regular Dog Walking Clients: I do my best to be reliable & available most of the time. However, if I need to take time off or cancel walks for any reason (vacation, appointments, personal reasons, etc.), you will be notified at least 2 weeks in advance.
